SUBJECT: Validation of Attendance for Professional Development Hours

This memorandum provides the formal documentation of attendance and one (1.0) professional development hour earned for the presentation on 19 November 2020, via GoToMeeting.

This presentation, by David Brearley, responsible for HDR's Cybersecurity team and the execution of the Department of Defense (DoD) Risk Management Framework for adherence to UFC-4-010-06, covered current DoD requirements for implementing cybersecurity into the design of Facility Related Control Systems or FRCS. A control system typically consists of networked digital controllers, sensors, and a user interface which are used to monitor and control equipment such as building control systems, utility control systems, electronic security systems, and fire and life safety (FLS) systems. This type of technology is also called Operational Technology, or OT, which is different from Information Technology, or IT, associated with computers that primarily process and store information. Larger more complex OT systems like SCADA (Supervisory Control and Data Acquisition systems) can also include devices typically associated with IT to include laptops, workstations, and servers. At the end of this session, attendees had a general understanding of these requirements, the process for designing for UFC 4-010-06 compliance, the approximate level of effort for a notional DoD facility, and some of the key people that need to be engaged early on in the design process when dealing with controls systems both internally and externally.
