Letter of Appointment, SAME IGE Project: "Challenges Facing Transitioning

Federal Small Businesses: A Proposed Framework and Solution"

Dear Rob,

Per your letter of Appointment dated September 24, 2021 following please find the requested Scope Document.

A. Issue Description, scope of the project

Too few small business federal prime contractors successfully transition from small to other-than-small and continue to win federal awards. The challenges of making the transition from small to large and the drastic change in competitive landscape often lead firms to exit the federal market or stifle normal business growth trajectories in order to take advantage of small business set-asides. This results in a stratified market wherein there are fewer firms competing in the mid-sized arena, leaving Government procurement officials with fewer qualified contractors. This directly affects the Government's ability to meet mission requirements.

The project scope is to push for the implementation of a win-win solution to this transitioning problem. The proposed solution is a Moratorium program and the goal is to push for a "Pilot Program" focusing on NAICS 236220 which was studied in detail.

B. Impact or Intended Outcome(s)

SBA implements a five-year (5) moratorium program for businesses in NAICS Sector 23 enabling transition into the unrestricted market. A five-year moratorium would aid the transition once the \$39.5 million 5-year average revenue cap has been exceeded and substantially alleviate the current obstacles small businesses face as they transition into the unrestricted market
