1. Any revisions to the draft Nov 10Post Board meeting minutes distributed by Sarah on Nov 30?

#### NO revisions needed. APPROVED as written.

2. <u>Board E-Vote</u>: On Nov 22 the Post Board approved by majority electronic vote the recommendations of the Post Scholarship Committee (see *Attachment 1*) to award 13 college scholarships totaling \$40, 000 to students from 6 different Texas Universities (TAMU, Texas Tech, UT Austin, UTSA, UT Arlington, and UT Tyler).

  - o 2022 Average attendance for the year was 51 and we issued 178 PDH certificates for the year
  - o 2022 net revenue was \$616.
- Attachment 4 is the draft 2023 Budget package from the inputs received.

Sam let the board know that he has issued all the checks for the student scholarship winners, but none have been cashed yet. Sam also let the board know that he is retiring soon and to use his personal email from here on. Dick discussed attachment 3 about our Post meetings and said that the most revenue came from the virtual meeting and the \$10 fees to attend. Dick went on to discuss attachment 4 regarding the Post budget; Glen motions to approve the budget as shown. Dick interrupted to highlight a few increases/decreases that were made based on what had been spent in previous years. Don Gleason wants to increase part of the scholarship budget from \$1,000 to \$2,000. Dick thinks we will only have a \$40-45K in revenue in 2023 due to both National events happening in SA and the Post decreasing the size of our normal events. Dick proposes going back to \$41K for the scholarship budget; Terry Watkins seconds this. The board APPROVES the budget for 2023 with the two changes. Bonnie stated that the SBMRF committee hasn't met yet regarding changes that will be made in size and pricing for 2023. Hilda went on the suggest potentially NOT hosting a holiday gala in 2023 after having some many large events but instead doing something smaller. Bonnie suggests revisiting this closer to the end of the year before making any kind of decisions regarding events and scholarships. The Board approved the preliminary 2023 budget with the revisions as discussed (see *Attachment 4* for the approved budget).

## 6. Holiday Gala:

• Update from committee members on Dec 9 Holiday Gala

Hilda let the board know about the current registration numbers (75 attendees) and the general program for the party. The goal is to make it more of a party and less administrative. Sam let Hilda know that he has sent all payment for the hotel and the only outstanding payment is the remainder of the casino rental.

## 7. Post Leaders Workshop (PLW)Follow-up:

- Zak Payne and John Baker attended the Aug 2022 PLW.
- One question on the Post Annual Report submittal addresses whether your Post has implemented anything from the PLW.
- Zak suggest that two items from Post Leaders Quick Reference Guide from the PLW on IGE and/or a sustaining member tutorial on the new membership structure are two potential items to focus on.

Dick discussed the PLW follow-up and focused on the Post Annual Report. One part of the report is asking what attendees took away from the last PLW; Dick reached out the Zak and John to get their input. Dick wants to know how we're going to hit the IGE focus at the 2023 March SBMRF conference. Zak discussed the membership changes and has been talking to National about how these changes are going to affect companies and members and suggests creating a tutorial or guide on how to navigate the new system. Zak concurs with Dicks concern about the IGE factor but thinks there is plenty of interest with organizations we already have relationships with that we can reach out and use. Multiple board members expressed concern about the new membership structure and how it is going to affect companies and predict a decrease in interest and membership (individual and sustaining membership companies) because it is confusing and potentially not beneficial for some companies. Josh will get together with Zak and the companies who are currently going through the renewal process to try and figure out a way to create a guide for going through the process and provide the info to Michele Torres to assist sustaining members. The purpose of the system change is to clean up the membership data to get a more accurate representation of members and not have duplicates on rosters.

### 8. College Outreach:

• On Thursday night Nov 10Chapter Faculty John Walewski welcomed 10 Texas A & M University students to the first meeting of the SAME Student Chapter for the 2022-2023 school year. Also present were representatives of the Houston-Galveston (H-G) and San Antonio (SA) Posts, including Buddy Barnes and Justin LaPorte from H-G Post, John German from the SA Post, and Trey Morgan from the Architecture Department (representing Dr. Pat Suermann, the Interim Dean of the College of Architecture, and a Director of the SA Post).

- UTSA Student Chapter held a meeting on Nov 18 at the Chicken and Pickle to celebrate the Chapter's win of the Distinguished Student Chapter award. There were about 13 people attending and attendees had a table inside the facility as it was a little chilly that evening. The event started at 5:00 PM and went past 7:30 with a lot of great discussion and camaraderie. One item discussed was increasing the scholarship applications by getting something started to begin the application process in the spring with several indicating they would be interested in doing so.
- On-line Student Chapter Status Reports are due Dec 1.
- We were asked by one of a current SAME LDP participant to assist with a survey on any follow-on actions taken
  with student winners of Post college scholarships. Email was forwarded to Diane Glass. Survey response is due
  Dec 31.

John German reviewed the TAMU Student Chapter information and the meeting that was held on the previous Thursday. They are looking to host another meeting either late January or early February. John also wants to have a scholarship presentation for the winners since there were 5 of them from TAMU. Terry briefed on the notes in the agenda regarding the UTSA chapter's events and meetings; the officers met and discussed ways to better plan for future events and are looking to host a recruiting event in the spring. Dick thinks a 2023 goal should be to get a student chapter to submit for the Innovation Design Challenge at National. Diane Glass is working the input on our scholarship program for the SAME LDP participant.

### 9. STEM:

- Harold Eberbach and Dick Kochanek participated in a virtual Facilithon event in Wisconsin on Monday. This
  event was different than previous Facilithons because we had a Facilithon team advisor rather than the team
  students participate as the competitor. Like other Facilithons the competitor took a 50-question facility related
  quiz, addressed a facility issue scenario, and then responded to a short notice facility management challenge
  related to the scenario. The scenario involved a hospital closing.
- We have 4 volunteers (Fred Belfort, Harold Eberbach, Dick Kochanek and Joe Stone) scheduled to participate at the John Jay Science & Engineering Academy Academic Research Symposium (the rebranded Science Fair). One of the high school senior winners will be selected for a Post college scholarship.

Harold briefed on the notes provided in the agenda and highlighted his and Dick's involvement in the Facilithon event. Harold also discussed the upcoming John Jay event and how the post will be awarding a scholarship and is looking for other new opportunities for 2023.

### 10. Leadership & Mentoring:

- Leadership Lab we continue with one session in Nov and Dec 2022. In Dec we will conduct the team building at the Newcombe Ranch in New Braunfels. Planning is underway for SAME and Community events in 2023. As always, if you want to sit in, board members are welcome. Just let Don or Cathy know for lunch numbers.
- Texas LDP applications closed on 31 Oct with 13 applicants, all are being accepted. Sessions start in Jan 2023. We are now seeking mentors for this group. We are working with our fellows, but if you have an interest or know of a great mentor, contact Don Gleason.
- SAME LDP Deadline extended from Dec 2 to Dec 7. Rene Cortez is applying.
