What Is A Teaming Agreement?

"Teaming Agreement"

- > No FAR definition.
- > A written document that memorializes team arrangement.

"Contractor Team Arrangement"

- > A potential prime contractor agrees with one or more other companies to have them act as its subcontractors under a specified Government contract <u>or</u> acquisition program (*i.e.*, Vertical).
- > Two or more companies form a partnership or joint venture to act as a potential prime contractor (*i.e.*, Horizontal) (FAR Subpart 9.6).

Policy

> Teaming Agreement is acceptable if identified and company relationships disclosed in offer or, for post-offer arrangements, before the arrangement becomes effective. (FAR 9.603)







Teaming, Joint Ventures and the SBA Mentor-Protégé Program

What Is A Teaming Agreement?

Distinguish: "Subcontract" (FAR 44.101)

> Any contract entered into by a subcontractor to furnish supplies or services for performance of a prime contract or a subcontract. "Subcontractor": Any supplier, distributor, vendor, or firm that furnishes supplies or services to or for a prime contractor or another subcontractor. (FAR 44.101)

Other Type of Teaming Agreement

> GSA Schedule Contractor Team Arrangement (CTA)

Teaming, Joint Ventures and the SBA Mentor-Protégé Program

Why Should I Team (Or Not)?

Depends on Perspective

> Prime / Sub / Big / Small / Experienced / New

PROS

- > Expand Skillset, Technical Capability, Competitiveness, Experience, Past Performance, New Markets
- > Meet Customer Expectations and Expand Ties
- > Share Cost, Share Risk of Loss, Lock in Partner

CONS

- > May Lose Independence and Control, Internal Organic Skill Development, Profits, Internal Information
- > Dependence on Others and Risk of Other's Failure
- > Creation of Competitor

Teaming Process

Teaming Agreement >>> should come at end of process

> What is business goal for particular situation? >> Do you need or want to team ("Make or Buy?") >> Market Research >> NDA >> Due Diligence >> <u>Teaming Agreement</u> >> <u>Subcontract</u> / <u>JV</u> for Project

Enforceability Considerations

> Agreement to Agree vs. Definitive Agreement vs. Partial Enforceability

Scope And Terms Of (Vertical) Teaming Agreement

No Cookie Cutter Teaming Agreements

> Negotiations reflect tension between Primes' and Subs' interests, leverage and goals

Key Terms for Enforceability

> Preamble; Intent for Binding Agreement; Term (Duration / Termination); Exclusivity; Mandatory Subcontract Language; Subcontract Terms; Subcontractor Workshare (SOW); Subcontractor Pricing; Remedies

Other Terms

> Non-Solicitation or Competition; OCI; Costs; Disputes; Governing Law; Termination; Limitation of Liability; Communication with Customer; IP, Confidentiality; Compliance / Certifications; Flow Downs; Boilerplate (Notice, Publicity, Severability, Assignment, Survivability, Force Majeure, Waiver, Incorporation, Amendment, Headings and Recitals)







Teaming, Joint Ventures and the SBA Mentor-Protégé Program

Joint Venture Overview – Horizontal Team

What is it?

> A JV is a new entity comprised of multiple entities combining resources to pursue a business objective.

Types

- > Contractual JV (Partnership)
- > LLC
- > Corporation

Effect

- > Members / Shareholders: Share proportionate share of profits and loss.
- > Partnership: Equal share of profits / losses and liable to each other's actions and liabilities







Teaming, Joint Ventures and the SBA Mentor-Protégé Program

Joint Venture Overview – Horizontal Team

Status

> Initially, JV has no history of experience or past performance (may sometimes rely on members past performance).

Populated or Unpopulated

> SBA now bars "populated" JV for small business / mentor protege JVs.

Key Terms In A JV

- > Form: Operating Agreement, Articles and Bylaws or Partnership Agreement
- > Purpose & Scope
- > Ownership / Contributions / Distribution / Voting
- > Control / Management
- > Succession
- > Taxes
- > Liabilities / Indemnification
- > Transfer / Dissolution / Term and Termination
- > Boilerplate Terms









Teaming, Joint Ventures and the SBA Mentor-Protégé Program

What is the SBA Mentor-Protégé Program?

- > Started with the 8(a) Mentor Protégé Program and extended into the All-Small Mentor-Protégé Program before merging into the current Mentor Protégé Program.
- If done properly, two or more small businesses or a large business and a small business can joint venture as a small business or other type of socioeconomic concern and compete for set-aside contracts.
- > Can provide an exception to affiliation.

Teaming, Joint Ventures and the SBA Mentor-Protégé Program

Why Participate in the Mentor-Protégé Program?

Benefits to Protégé

- > Guidance on systems, accounting, marketing, strategic planning, and the procurement process.
- > Financial assistance in the form of equity (up to 40%) and debt investment.
- > Leverage the Mentor's past performance, experience, and reputation.

Benefits to Mentor

- > New pool of contract opportunities (e.g., if other than small) and large workshare allocation (up to 60%).
- > Improved skill sets (e.g., internal employee teaching or enterprise level) and new customer relationships.
- > Potential investment or acquisition target or long-term relationship.
- > Resource for innovation.







Teaming, Joint Ventures and the SBA Mentor-Protégé Program

How to Participate?

Qualifications

- > Protégé size and socioeconomic eligibility
- > Mentor character and skill qualifications

Formation and Approval

- > SBA Approval of the Mentor-Protégé Agreement (Mandatory terms)
- Joint Venture as an unpopulated separate legal entity (e.g., separate EIN, SAM, DUNS, CAGE)
- > Compliant Joint Venture Operating Agreement (No SBA Approval)

Performance

- Limitations on subcontracting (JV can subcontract no more than 50% unless sub is similarly situated)
- > Internal workshare split if there is a large business or a specific socioeconomic category (e.g., 60-40%)

GSA Contractor Teaming Arrangement

- > See GSA.GOV website
- > Two or more GSA Schedule Holders
- > Two primes / One takes administrative lead
- > Expands offerings
- > Each entity invoices at its rates / prices
- > Not a FAR Subpart 9.6 Contractor Teaming Arrangement
