Brian Schuele presented the **monthly income report** along with the **"budget vs actual" income & expense report** (see attached). Further, much discussion ensued as he briefed the **budget worksheets**; with the proposed changes, we plan to vote on this year's budget in February. Brian will update and send to the Board members. (The worksheets are not attached here but will be included with the February agenda.)

During budget discussions, Anne remarked about their planned 14 Feb **Leadership & Mentoring** "E-week SMP" event, needing a host location, and also now a speaker. Both Veronica Doga and Stephanie Ling offered to inquire about UNO and MCC (respectively) venues to host. Further, we discussed adding two discrete budget line items; Brian will adjust the worksheet to suit.

Tom Svoboda briefed we are now an **E-week** "diamond sponsor" with the NU College of Engineering event. He asked for volunteers to judge and assist. Brec, Dave, Karlus, and Bobbi assented to help.

Phil Deakin reported on the planned **Fellows** meeting in February. He also reiterated the success we saw in the last Fellows application process and how we might project & guide new applicants.

We heartily thank Joe Shields for accepting the chair of **Scholarships & Camps** and welcome him back to the Omaha Post Board of Direction. During discussion, Nicole Hunter offered to call each current scholarship holder so each might renew their AY filing before 1 Mar 2023. She will also send promotional SAME Scholarships materials to the current SMP teacher and mentors.

Bobbi Jo Lang reported we presently have 743 members. She continues sending **Relationships** emails to the whole group.

Kandi Srb reports **Industry Day** registration with "go live" o/a 15 Mar 2023. We are still soliciting sponsorships and a keynote speaker. As an alternative to gain participation from non-golfers, we are offering a "walking tour of the Leahy Mall" simultaneously with the Golf Outing.

Kandi Srb and Chris Artz briefed the current **Programs** list (shown now on the first page next to it's respective date) and how the committee is expanding the topics list.

Veronica Doga reported an idea spawned by her attendance at the **Small Business** COI meeting; she would be happy to facilitate reaching out to new Industry Day attendees prior to the event and meet/talk with them about expectations. She also wants to pass some program ideas to Dave Packard (including "something for SB on CMMC, FOCI, or SB MPP").

## Natasha handed off meeting leadership to Anne and left the meeting at 12:59pm.

Ryan Watzke briefed the current Post webpage, and **Communications** materials posted there. He will coordinate with Natasha to update her Presidents' message; additionally, there is no date projected when these "classic" elements merge into National's SAME webpage. Bobbi will send Phil an updated Sustaining Member list.

Stephanie Heibel reported that although she submitted our Streamer application early—since her **Awards & Recognition** spreadsheet contained more than sufficient justifications—we can still add inputs until the end of January.
