#### TREASURER (Ryan Peterson)

- Only expense was the annual re-registration with WA state.
- Upcoming month: Ryan will be asking committee and chair heads what their next year budget request would be so Ryan can submit to the board and vote on it.
- 2022 budget will come out shortly.
- Total income from last year: in the \$5K-\$10k range.
- Totals for the entire year: last page of the treasury report.
- Revenue and expenses:
  - o This year, about \$16k in revenue and \$39k in expenses.
  - o \$20k of that was for scholarship contribution.
  - o About even for revenue and expenses.
  - o On the same track compared to last year.

- Not much new to report.
- Should be hearing back on the fellow's nominations.
- Have two that we submitted and should hear this month.
- In January, Larry will be sending out a notice in regards to interest in Board of Directors post positions.



- Bo is transitioning across the county. Allen will be taking over as President.
- Will need people for first VP and second VP position. Have elections at the May meeting.

#### PROFESSIONAL DEVELOPMENT (Wendy Oresik)

- Owe April R. certificates to circulate.
- Wendy will give Terry a list.
- Wendy used to physically hand them out at the meetings and will need to electronically send those out.
- Wendy to meet with Jackie and April R. to discuss distributing those certificates.

#### SCHOLARSHIPS (John Souza)

- Would like to know allocations for this year. We plan to role out and start advertising in January and kick off program in late January.
- Sponsored scholarships likely to have another big year.
- Revenue has decreased, \$20k a year for scholarships and think we may need to cut in half.
- \$10k donation and \$5k to students: Ray's proposition.
- Any scholarship we give, that we also assign them a mentor: someone to check in with the student at a minimum quarterly.
- Could add it to the point system. Get extra points if you are a member or student member, etc.
- There is an agreement in place between Seattle Post and Puget Sound Scholarship Fund which provides some of the funding for these scholarships. This funding is for high school seniors or post member sponsor candidates: can be high school seniors or students in college seeking BS degree.
- It is the sponsor scholarships (that are sponsored by certain firms or individuals) where the stipulation that the student must be involved in SAME activities needs to be in place.
- If we are going to require memberships in a student post, will be difficult for high school seniors seeking the scholarship. But we can make it a stipulation on the sponsored scholarship. Just would need half to go to any high school seniors, other half could be for SAME chapter members.
- We have about 10 companies / individuals giving the sponsored scholarships. These are available to college students who have at least one year of college done.
- On Seattle post sponsored scholarships, we can give additional points if the candidate is a young post member (as long as candidate is current college student).
- Another idea student chapter president gets an automatic scholarship...encourages participation in the student chapter.
- Want to put more emphasis in the local area.

- We have three different accounts; one is education and mentoring fund (no expenses except scholarships). Right now that account has \$10.7k, around \$10k to PSE and SSF scholarship would be good because it matches what we have set aside for this purpose.
- Board thinks we should stay towards \$20k. The golf tournament was a major money maker for scholarships.
- Design Excellence: Net was \$5k-\$10k.
- Ryan will come back on financials with what we make in each event. Finalize in January. Placeholder for now is: \$20k motion approved.
- How to get people actively involve din SAME a better opportunity to earn a scholarship?
  - o A: Do nothing
  - o B: Increase point system
  - o C: make requirement to be SAME student chapter members
- Point system idea is approved by majority.
- We have a rubric for scoring, John can give an idea at the next meeting for how that looks for the joint funded scholarships.
  - o Also, could have the sponsored scholarships come up with their own criteria.

#### SMALL BUSINESS COMMITTEE (Lori Revely)
