VA Mission & Vision

Mission

 Advance VA's mission in support of our Nation's Veterans by planning, designing, constructing and acquiring major facilities, and setting design and construction standards.

Vision

 Be the trusted leaders in delivering healthcare and other facilities for our Nation's Veterans.



VA Facilities Inventory

- 6,232 Owned Buildings
- Over 155 Million Owned GSF
- 1,921 Operational Leases
- Over 24 Million Leased SF
- Over 36,000 Owned Acres of Land
- Average age approaching 60 years; Over 2,200 historic buildings



Major Construction

- Projects with a cost greater than \$20 Million
- Requires a line item appropriation by Congress
- Also requires a specific authorizing legislation for medical projects
- Typically designed by an Architectural/Engineering Firm and constructed by a general contractor
- DBB and DB procurement

Minor Construction

- Projects with a cost less than \$20 Million
- Appropriation by Congress not project specific
- Designed by an Architectural/Engineering Firm and constructed by a general contractor
- Typically administered at each medical center, cemetery or VBA office building



- Non-Reoccurring Maintenance (NRM)
 - Primarily address correcting facility deficiencies and renovating existing space Including the repair or replacement of existing building systems
 - Typically administered at each medical center or cemetery
 - NRM projects are funded through the VHA's medical facilities account or NCA's operations and maintenance account
 - Designed by an Architectural/Engineering Firm and constructed by a general contractor
- Green Management Program
 - Under Control of the Office of Asset and Enterprise Management
 - Energy Conservation Programs
 - Energy Generation Programs
 - Energy Assessments



Leasing

- Congressional approvals if rent is greater than \$1 million
- Varying approvals required based on space and rent levels
- CFM's Real Property Service manages the acquisition of large leases
- Local or VISN personnel manage smaller leases
- Typically contract with a developer
- Large Leases and Build-to-Suit
- Chip In (P3)



- VA Provides Planning, Project Management, Design Management,
 Construction Management, Activation and O&M.
- CFM is responsible for providing management and on-site supervision for design and construction of VA's Major Construction projects. Major Construction encompasses projects greater than \$20 million and includes a large and complex inventory of approximately 53 active projects valued at \$11.6 billion total, as well as projects associated with the new 2019 Seismic Corrections line item (next slide) to address all seismic construction projects.

VA USACE Partnership

- The Department of Veterans Affairs Expiring Authorities Act of 2015 requires the VA to enter into an agreement with a non-Department Federal Entity to provide design and construction management services for all construction projects with a total estimated cost over \$100 million (Super Construction Projects).
- VA has entered into a preliminary agreement with the US Army Corps of Engineers (USACE) for VA CFM Major Construction Program to serve as construction agent for projects over \$100 Million.
- 17 Partnered projects as of FY19
