


- 1. Roll call (see page 1).

- 4. Approval September 7, 2023; AGENDA. APPROVED
- Announcements.
  - i. We have a new officer position and three new committee positions to vote on today. Scott Kinney for Post Secretary, Kim Baker moving from Outreach Committee to Membership Committee, Manny Bautista for Post Fellows POC, and Michael Albone for Veterans Assistance. All new officers approved.
  - ii. Northern Tier RVP requests that we vote on financial assistance to the Lewis and Clark Post. Their Tri-Cities Field Chapter had to cancel an event last spring and the Post needs \$3000 to cover cancellation expenses. 


